

# LAND ACKNOWLEGEMENT



The city of Brantford and surrounding area is on the traditional territory of the Anishinaabe, the Haudenosaunee and the Neutral Nations. This land is subject to the Haldimand Treaty of 1784, which guaranteed the exclusive use of 950 000 acres along the Grand River for members of the Six Nations. To this day, through processes of colonialism, racism and genocide, settlers have secured 902 000 acres of the Haldimand Tract for their own, leaving 48 000 acres for members of the Six Nations.

B.R.A.V.E. is committed to efforts of ongoing reconciliation and decolonization, based on the needs and suggestions given by Indigenous members of B.R.A.V.E. and Indigenous people within the Brantford and surrounding communities.






# Brant's Response Against Violence Everywhere

The B.R.A.V.E Committee was established under the leadership of the Crown Attorney's Office, Ministry of the Attorney General in 1998 as D.A.R.T. (Domestic Assault Review Team for Brant County). In 1999 the committee adopted its new name B.R.A.V.E (Brant's Response against Violence Everywhere)

Using a gender based analysis framework, the B.R.A.V.E Committee coordinates the community's response to gendered violence, domestic violence and sexual violence. Informed by an anti-oppressive, equity-seeking, intersectional lens, B.R.A.V.E responds to these forms of violence through: advocacy for improvements in existing systems, prevention and intervention initiatives, coordination and improvement of the flow of information between agencies to ensure a sound knowledge base for the application of domestic violence and sexual violence protocols, the promotion of education and training amongst agencies, and increased accountability in the delivery of each member agency's respective service.







# MESSAGE FROM B.R.A.V.E

The Rural and Remote Supports and Services project is funded by the Ministry of Children, Community, and Social Services (MCCSS).

The purpose of this funding and report is to improve the capacity of gender-based violence service providers to effectively respond to the unique and complex needs of women and their dependents who have experienced violence or are at-risk of experiencing violence in/from rural communities.

The report shows findings on improving capacity in Brant County and Six Nations.

For the purpose of this initiative, rural communities are defined as those communities that have limited local services, are far from urban centres, and/or are without year-round road access. In addition, rural communities tend to exist in geographic areas where there is relatively low population density, or limited access to services.

The goal of this initiative is to:

1.) Strengthen delivery, including through partnership development and collaboration with other community organizations in order to provide effective crisis and community supports.

2.) To reduce geographic and transportation barriers to improve access to gender-based violence services and safe spaces.

We thank the Ministry for providing the funding for carrying out this project, and we hope increases the capacity for providing services needed in Brant County and Six Nations




# POPULATION OF BRANTFORD, BRANT COUNTY, AND SIX NATIONS





# **METHODOLOGY**

A questionnaire was sent out to B.R.A.V.E member agencies for the purposes of gathering information for this report.

The questionnaire was sent out to the 27 B.R.A.V.E member agencies. Of the 27, 8 agencies responded. Data specific to services provided in Brant County and Six Nations are from the responses.

Additional data has also been sourced from the B.R.A.V.E produced Refrigerator Door Handbook, which is a curated guide on community resources members of Brantford, Brant County, and Six Nations can access when navigating their domestic/sexual violence situations.

The following questions were asked:

- 1.) What is the name of your agency?
- 2.) What services do you provide?
- 3.) Where are your services physically located (Brantford, Brant County, Six Nations, and/or Other)
- 4.) Which of your services are available/accessible to members in rural and remote communities?
- 5.) How do clients living in rural communities access these services? (Offices located in rural community, Text-messaging, Mobile Outreach Worker, Internet-based Services, Transportation provided to City-based services, Other)

- 6.) Considering the clients who access domestic/sexual violence services from your agency, what percentage (%) are from rural communities?
- 7.) Do you think additional and/or more accessible services for sexual/domestic violence are needed in Brant County (please explain)
- 8.) What type of barriers do you think exist in accessing services for survivors of domestic and/or sexual violence in Brant County/ Six Nations?
- 9.) What do you think are the best ways to increase access to services for survivors of domestic violence and/or sexual violence in Brant County/ Six Nations? [ Please rate the following from least important to most important]
  - Services located in Brant County and/or Six Nations
  - Mobile Outreach Worker
- Offering transportation to support services located in Brantford (e.g. via taxi, volunteer drivers, mileage costs, pay for gas)
- . Internet-based video-counselling
  - Other





- \*The second suggestion for "Other" supports was: giving out vouchers for taxi services or developing an agreement with taxi services




# HOW DO CLIENTS LIVING IN RURAL COMMUNITIES ACCESS THESE SERVICES

Ganohkwasra is located in a rural community. They are located in Oshweken. People sometimes cannot get rides to Oshweken to attend their appointments

# LIMITATIONS

There was limited time and funds to conduct this research in a manner that would yield holistic results

Agencies do not keep readily available statistics on how many people from rural communities are accessing their services as they do not have the resources required to make this happen.

A big limitation for this research is the inability to gain perspectives from all stakeholders; primarily residents of Brant County and Six Nations, including City and Government workers.

This research is not reflective of the experiences of the Six Nations Community. B.R.A.V.E. supports the allocation of time and resources to further understand the priorities of this community if that is deemed relevant by them.

This research does not indicate how Indigenous people living in Urban areas are accessing traditional healing practices, and what the barriers are to that access.





# **Brantford Native Housing**

Brantford Native Housing is a non-profit Charitable Corporation whose main objective is to provide safe, secure, and affordable rental homes for Urban Natives living in the City of Brantford . B.N.H offers housing to Status, Non-Status, Metis and Inuit families of low income. To be eligible for housing a minimum of 50% of all family members must be of Native Ancestry. Three Housing Programs allow B.N.H. to provide subsidized rental units. The subsidies allow tenants to pay approximately 25% or 30% of their earned gross income depending on the housing program for a fully serviced unit, excluding Public Utility Costs. All applications and information are kept confidential. B.N.H. presently has a housing portfolio of 159 homes, which are scattered, throughout the City of Brantford.














# **Ganohkwasra Family Assault Support Services**














#### **Nova Vita Domestic Violence Prevention Services**


# The Bridge



- Victim Crisis Assistance Ontario (VCAO). The VCAO program provides support for individuals affected by crime and tragic circumstance. Victim Services of Brant can provide crisis intervention, emotional support, practical assistance, and can make referrals to community agencies for long-term assistance. We help clients identify and address safety issues to help reduce the likelihood of further harm and develop strategies to address them.
- Victim Quick Response Program (VQRP). VQRP contributes financial assistance to victims who have suffered physical or emotional harm as a result of a violent crime (listed below, as well as property offences that compromise victim safety in cases of domestic violence, sexual assault and hate crime). The VQRP program is one of last resort; therefore it is not available to those with insurance coverage. VQRP will not contribute to any insurance deductible.
- Safety Planning. Victim Services of Brant Safety Plan program is designed to provide victims with personal safety plans. Ongoing follow-up is available.
- Court Assistance Program. Victim Services of Brant provides Court Support Staff to support victims at the initial stages of the court process.







### DO YOU THINK ADDITIONAL AND/OR MORE ACCESSIBLE SERVICES FOR SEXUAL/DOMESTIC VIOLENCE ARE NEEDED IN BRANT COUNTY?

Overall, responders feel that services provided to people living in Brant County and Six Nations need to be made more accessible. Given how close-knit and rural communities are, people accessing services may not wish to do so in the town they are living in. Sexual and Domestic Violence carries a particular stigma, and rural women are seen as violating community norms by their peers or families if they disclose their experiences. By accessing services within the community, for some this could result in a breach of confidentiality; which, could determine a person's access to safety within the community (Pietsch, 2018). Moreover, while violence creates a side-effect of isolation, for any survivor living in a rural environment, the desire to break from the isolation is exacerbated and the barriers to do so are heightened. Conditions of rurality, such as long distances, lack of transportation, limited services, and rigid, small town social structures further complicate the isolation experienced by rural women (Pietsch 2018). As such, they would prefer coming to services in Brantford. However, access to transportation is not always available. Therefore, funding to provide transportation for clients would eliminate that barrier to access, and allow people to go to their appointments, without having to cancel them due to the barrier in access to transportation. Transportation to and from Oshweken from Brantford is also vital, so that Indigenous people living in Brantford can access culturally appropriate services in Oshweken.

Better public transportation between Paris and Brantford would also be of help, so that Paris community, or rural clients attending at hospital or other services in Brantford as presently the bus between these two areas does not provide good, effective transportation services for clients needing to come into Brantford.

For the people who do wish to access services within their own communities, having offices, satellite services, and mobile outreach in Brant County and Six Nations would be an added benefit. Having weekly, part-time satellite offices/services in local rural communities in St. George, Burford, Paris etc. is a recommended place to start.

Lastly having access to services is important, but equally important is access to knowledge of these services is important. Having outreach workers to do knowledge-translation work is important, as is utilizing the Outreach workers to spread knowledge of what services are available, and how folks can access them.

# WHAT TYPE OF BARRIERS YOU THINK EXIST IN ACCESSING SERVICES FOR SURVIVORS OF DOMESTIC VIOLENCE AND/OR SEXUAL VIOLENCE IN BRANT COUNTY/SIX NATIONS?

The type of barriers in accessing services for survivors of domestic and sexual violence in Brant County and Six Nations can be broken down into:

- Geography
- Transportation
- Close-Knit Communities

Knowledge

History

#### **Geography:**

People living in rural communities are geographically distant from most of the services available in Brantford. This already creates a barrier for people who are living in greater isolation to have ease of access to DV/SV services available. This distance creates a barrier to accessing support from counsellors or other professionals. Within the communities, having access to larger plots of land means they can also be physically distant from each other, and the potential informal peer support that can be provided.

Rural living also means there is a lack of reliable or affordable internet or phone support. This can make it difficult to access knowledge of services, updated, and/or to call to make appointments, or access the appropriate transport to get to the services.

#### **Transportation:**

Limited access to transportation makes it very difficult for people living in rural communities to access services in Brantford, or for Indigenous people living in Brantford, to access culturally appropriate services on Six Nations. Awareness of what services provide transportation is also not easily accessible/available.

#### **Close-knit communities:**

Rural communities are very close-knit, and as such, most people know each other, and what is occurring in each other's lives. Domestic and Sexual Violence are tabooed topics, and a lot of the violence is hidden away. Disclosing sexual violence can threaten an individual's access to safety either by the counsellors/service providers breaching confidentiality, or by the abuser who would seek to isolate the individual from their support networks.

Gaining access within rural communities is also difficult. Having consistent and sustained reach is important to developing trust in rural communities.

# WHAT TYPE OF BARRIERS YOU THINK EXIST IN ACCESSING SERVICES FOR SURVIVORS OF DOMESTIC VIOLENCE AND/OR SEXUAL VIOLENCE IN BRANT COUNTY/SIX NATIONS?

#### **Knowledge:**

For some communities, sexual and domestic violence is not discussed. There can be a lack of knowledge on what SV/DV is, what it constitutes, what healthy relationships can look like, and what the available options are. Further, additional funding is required to have more educational outreach opportunities by services in Brantford, and to do so in appropriate, and sustained manners, that center the needs of the communities.


#### **History:**

Finally, history plays a big role in navigating social service spaces and access to them. The colonial history of Canada, and the role that social services have played previously in carrying out the genocide against Indigenous communities has resulted, rightfully so, in a great degree of mistrust. Decolonizing social service practices is fundamental to providing appropriate, accessible, and trust-worthy service.











### RECOMMENDATIONS FROM THE RESEARCH

This project requires more time and funds to gain a holistic insight into barriers to access; as well as to collaborate to reduce those barriers.

The City should invest in providing more accessible public transportation options - this includes cost of public transportation, routes, times available, and means of transportation.


The government should provide increased funding to social services to give the option of providing public transportation to their clients.

Increased funding is needed to create offices/satellite offices in rural communities; or to have the capacity to have weekly hours in satellite offices.

Funding needs to be given to the Six Nations community to invest in research that is inclusive of the unique barriers and needs that impact their community.

Social Service agencies should actively keep track of statistics as they relate to rural communities, and should be actively thinking about access provided and barriers to access.

Social Service agencies should indicate on their websites and other promotional materials what services are available to people living in rural communities, and how they can access them; including what supports the agencies have available to reduce the barriers to access.





### RECOMMENDATIONS FROM THE RESEARCH

Solutions/advocacy/campaigns that provide appropriate knowledge of sexual and domestic violence, as well as the options available are needed.

Solutions/advocacy/campaigns that address the need to invest more in Six Nations for their services and access to services for people living on Six Nations, Brant County, and Brantford.

Solutions/advocacy/campaigns that acknowledge and address the unique needs of rural communities.

Solutions/advocacy/campaigns that communicate that survivors exist in rural spaces and across vast geographies.

Solutions/advocacy/campaigns that bring together survivors in a safe setting, and that educate agencies on the importance of maintaining confidentiality for people living in Rural communities.

Solutions/advocacy/campaigns that educate bystanders/allies (family, friends, faithcommunities, schools, in rural contexts.
